4. General Body:

Annual General Body will meet once in a year i.e., on last Saturday of December. Venue: ANURAG Engineering College, Ananthagiri (V), Kodad (M), Nalgonda (Dt.), 508 206.

(i) Functions:

- To pass the budget for the ensuing year and approve the expenditure statement of previous year
- To approve the report of the activities of the association.
- To elect the executive Committee(E.C) etc.,
- To appoint Auditor.

5. Executive Committee:

- (i) Shall consist of Twelve(12), the following office bearers viz., President, Vice President, General Secretary, Joint Secretary, Treasurer. Executive committee members shall comprise of one from each department. However general body shall elect President, Vice President, General Secretary, Joint Secretary and Treasurer.
- (ii) The members of the Executive Committee (Governing Body) shall be duty bound to attest the signatures of all the members of newly elected Executive Committee and to see the said signatures of the outgoing Governing Body tally with the annual list as filed with the Registrar of Societies before 15 days the succeeding month in which elections were held.

SIGNATURE OF PRESIDENT SECRETARY

FUNCTIONS OF THE EXECUTIVE COMMITTEE AND OFFICE BEARERS:

- I. PRESIDENT: He presides over all the meetings of the general body and executive committee. He can cast his vote in the case of a tie in decision making. He can supervise all chapters of the Association.
- II. VICE PRESIDENT: He shall assist the president in discharge of his functions. In the absence of the President he will perform the duties of the President as entrusted by him.
- III. SECRETARY: He is the executive officer of the Association and custodian of all records relating to the association and corresponds on behalf of the association. He has to take on record all minutes of the Association. He would convene both the Executive committee and general body of the association with the permission of the President. He guides the treasurer in preparing the budget and expenditure statement to place before the general body for its approval, preferably the person residing in Hyderabad.
- IV. JOINT SECRETARY: He has to do the work entrusted by the executive committee. He has to assist the Secretary in discharging his duties, in the absence of the Secretary, he can perform the duties of the Secretary.
- V. TREASURER: He is responsible for all financial transactions and funds of the association. He has to maintain accounts properly along with the vouchers with the endorsement and approval of patron, the principal of ANURAG Engineering College.
- VI. OFFICE BEARER: They are the responsible persons to attend to such activities of the association which the executive committee entrust to them.
- VII. QUORUM: Twenty five members of the general body meeting and 1/3rd of members of Executive Committee meeting. In case enough members are not there, the meeting shall be cancelled and next meeting can be convened at the next convenient date and time for which requirements of quorum is not necessary.
- VIII. FUNDS: The funds shall be spent only for the attachment of the objects of the association and no portion where of shall be paid or were transferred directly or indirectly to any of the members by any means. The bank account will be operated jointly by the Patron, the Principal of ANURAG Engineering College and the Treasurer.
- IX. DECISIONS: The decisions can be taken by general body by simple majority. The executive committee may also take decisions by simple majority.
- X. AMMENDMENTS: No amendment or alteration shall be made in the purpose of the Association unless it is voted by 2/3 of its members present at a special meeting convened for the purpose and confirm by 2/3 of the members present at the 2nd special meeting.
- XI. WINDING UP: In case the association has to be wound up the property and funds of the Association that remain after discharging the liabilities, if any, shall be transferred or paid to the parent Institute viz., ANURAG Engineering College with similar aims and objects.
