1. The Main Project Viva-voice examination shall be conducted within two weeks after completion of the fourth semester end examinations.
2. A soft copy of the thesis should be submitted for ANTIPLAGIARISM check and the plagiarism report should be submitted to the Examination Branch and be included in the final thesis, after approval from the Project Review Committee (PRC).
3. The Thesis will be accepted for submission, if the similarity index is less than 30%. If the similarity index has more than the required percentage, the student is advised to modify accordingly and re-submit the soft copy of the thesis after one month. The maximum number of re-submissions of thesis after plagiarism check is limited to TWO.
4. The candidate has to register for the Project work and work for one semester. After three attempts, the admission is liable to be cancelled.
5. After evaluation and approval by the PRC, the student shall submit 3 copies of the project thesis certified by the supervisor to the respective head of the department.
6. The Chairman, BOS of the respective department shall submit a panel of 3 external examiners (with designation, experience, full address, mail id and contact number), who are eminent in that field with the help of concerned supervisor and Head of the department for a group of 4 or 5 students with details of i) H.T.No ii) Name & iii) Project title, to the Principal for approval.
7. The thesis shall be adjudicated by an examiner selected by the Principal / Chief Controller of Examinations from the panel submitted.
8. If the report of the examiner is favourable, viva voice examination shall be conducted by the board consisting of Supervisor, Head of the Department and the Examiner who adjudicated the thesis.
9. The Head of the Department shall coordinate and make the arrangements for the conduct of viva-voice examination.

10. A candidate must secure a minimum of 50% of marks to be declared successful.
11. If the student fails to obtain the minimum marks in 'pre-submission project seminar' or absent, he / she has to reappear for the same during the supplementary examination as and when notification is issued.
12. If the report of the viva-voice is unsatisfactory, the candidate will retake the viva-voice examination after 3 months. If the candidate fails to get a satisfactory report at the second viva-voice examination, he/she will not be eligible for the award of the degree.
13. The result of the viva-voice examination, along with an approved copy of the thesis shall be sent to the examination branch.
14. If the report of the examiner after adjudication of the thesis is not favorable, the candidate shall revise and resubmit the thesis, in the time frame as prescribed by PRC. If the report of the examiner is unfavorable again, the thesis shall be summarily rejected. Subsequent actions for such dissertations may be considered, only on the specific recommendations of the external examiner and /or Project Review Committee. No further correspondence in this matter will be entertained, if there is no specific recommendation for resubmission.
